Settlement Cycle Timelines

(May 2010)



1. Settlement Cycle Timelines

Market Rule 9.16 outlines the rules for Settlement Cycle Timelines and includes a requirement (at MR9.16.2) for the IMO to publish, one month prior to the commencement of a financial year, the timelines for settlement of amounts payable under the Market Rules for all trading days in that financial year.

The purpose of this document is to fulfil the IMO's obligations under MR9.16.2 for the financial year beginning 1 July 2010 and ending on 30 June 2011.

The IMO may revise any date in this document as appropriate.

1.1 Purpose

The purpose of this document is to provide:

- the settlement timeline for the STEM, in accordance with Market Rule 9.16.1;
- the timeline for Non-STEM settlements, in accordance with Market Rule 9.16.2;
- the Capacity Credit Allocation Submission timeline in accordance with Market Rule 9.16.2(b);
- the Meter Data Submission timeline, in accordance with Market Rule 9.16.2 (a);
- the timeline for Non-STEM Settlement Adjustments, in accordance with Market Rule 9.16.4; and
- the timeline for STEM Settlement Adjustments, in accordance with Market Rule 9.16.4.

1.2 STEM Settlement Timeline

Market Rule 9.16.1 stipulates that the settlement cycle timeline for the STEM is as follows:

- **STEM Settlement Statement** (for each of the Trading Days in the Trading Week) **and Invoice for the STEM Settlement Statements** - the first Business Day commencing after the end of a Trading Week.
- **STEM Settlement Date** (the date upon which transactions covered by a STEM Settlement Statement are settled) - the second Business Day following the date of the Invoice in relation to the STEM Settlement Statement is issued.
- **STEM Settlement Disagreement Deadline** - 5pm on the twentieth Business Day following the date the Invoice in relation to the STEM Settlement Statement is issued. A Market Participant has until this time to lodge a Notice of Disagreement with the IMO pertaining to any amount included in the relevant STEM Settlement Statement.

The timeline for STEM Settlements is contained in Appendix A.

1.3 Non-STEM Settlement Timeline

Market Rule 9.16.2(c) – (f), and 9.19.7 stipulates the timing for the following in each Non-STEM settlement cycle:

- **Non-STEM Settlement Statement Date** (the Business Day by which Non-STEM Settlement Statements for a Trading Month must be issued) - not less than three Business Days and not more than five Business Days after meter data submissions are provided to the IMO.
- **Invoicing Date** (the Business Day by which the IMO must issue Invoices for Non-STEM Settlement Statements for a Trading Month) - the sixth Business Day of the second month following the month in which the Trading Month being settled commenced.
- **Non-STEM Settlement Date** (the Business Day on which the transactions covered by a Non-STEM Settlement Statement are settled) - the eighth Business Day of the second month following the month in which the Trading Month being settled commenced.
- **Non-STEM Settlement Disagreement Deadline** - 5:00pm on the twentieth Business Day following the date on which a Non-STEM Settlement Statement was issued. A Market Participant has until this time to lodge a Notice of Disagreement with the IMO in relation to any amount included in the Non-STEM Settlement Statement.
- **Non-STEM Settlement Final Disagreement Deadline** - 5:00pm on the calendar day 9 months from the issuance of the original Settlement Statement. A Market Participant has until this time to lodge a Notice of Disagreement with the IMO in relation to any amount included in the Non-STEM Settlement Statement or an adjustment.

The timeline for Non-STEM Settlements is contained in Appendix B.

1.4 Capacity Credit Allocation Submission Timeline

Market Rule 9.16.2(b) stipulates the following timing rules for the Capacity Credit Allocation Submission timeline:

- **Earliest Submission Date** (and time) at which Capacity Credit Allocation Submissions for a Trading Month can be made - a Business Day after the end of the Trading Month to which the Capacity Credit Allocation Submission relates but not less than 10 Business Days prior to the Non-STEM Settlement Statement Date.

- **Latest Submission Date** (and time) at which Capacity Credit Allocation Submissions for a Trading Month can be made - not less than five Business Days prior to the Non-STEM Settlement Statement Date.
- Date (and time) by which the **IMO** must contact a Market Participant with a **request to nominate modifications** - not less than four Business Days prior to the Non-STEM Settlement Statement Date.
- Date (and time) by which a **Market Participant** must **respond to a request to nominate modifications** - not less than two Business Days prior to the Non-STEM Settlement Statement Date.
- **Acceptance Notification Date** (and time) by which the IMO will notify Market Participants from which the IMO has accepted Capacity Credit Allocation Submissions - not less than two Business Days prior to the Non-STEM Settlement Statement, but later than the time specified for Market Participants to respond to a request to nominate modifications.

The timeline for Capacity Credit Allocation Submissions is contained in Appendix C.

1.5 Meter Data Submission Timeline

Market Rule 9.16.2(a) stipulates that the Interval Meter Deadline, by which meter data submission must be provided for a Trading Month, is the first Business Day of the second month following the month in which the Trading Month commenced.

The timeline for Meter Data Submissions is contained in Appendix D.

1.6 Non-STEM Adjustment Timeline

The IMO undertakes a process for adjusting settlements ("**Adjustment Process**") at least once every three months. The purpose of the process is to review the relevant Settlement Statements to facilitate corrections resulting from Notices of Disagreement, the resolution of Disputes and revised metering data provided by Metering Data Agents. Adjustments may only be made to Relevant Settlement Statements. Adjustments may not be made to Settlement Statements outside of an Adjustment Process.

Market Rule 9.16.4 provides the timing for the following in each Non-STEM Settlement Adjustment cycle:

- **Non-STEM Settlement Adjustment Commencement Date** - the commencement date for the Settlement Adjustment Process.
- **Non-STEM Settlement Adjustment Statement Date** (the Business Day by which Non-STEM Settlement Adjustment Statements for a Trading Month must be issued) - not less than 20 Business Days after the Commencement Date.

- **Invoicing Date** (the Business Day by which the IMO must issue Invoices for Non-STEM Settlement Statements for a Trading Month) - not less than two Business Days after the Statement Date.
- **Non-STEM Settlement Date** (the Business Day on which the transactions covered by a Non-STEM Settlement Statement are settled) - not less than two Business Days after the Invoicing Date.
- **Non-STEM Settlement Disagreement Deadline** - 5:00pm on the twentieth Business Day following the date on which a Non-STEM Settlement Adjustment Statement was issued. A Market Participant has until this time to lodge a Notice of Disagreement with the IMO in relation to any amount included in the Non-STEM Settlement Statement. Note that Settlement Disagreements can only be lodged before the final Non-STEM Disagreement Date.

The timeline for Non-STEM Adjustments is contained in Appendix E.

1.7 STEM Adjustment Timeline

The IMO undertakes a process for adjusting settlements (“**Adjustment Process**”) at least once every three months. The purpose of the process is to review the relevant Settlement Statements to facilitate corrections resulting from Notices of Disagreement, the resolution of Disputes and revised metering data provided by Metering Data Agents. Adjustments may only be made to Relevant Settlement Statements. Adjustments may not be made to Settlement Statements outside of an Adjustment Process.

Adjustments to STEM Settlement cycles will be notified as required. It is not anticipated that a STEM Settlement Adjustment will occur under the current Market Rules.

1.9 Definitions and Conventions

All references to times are Western Standard Time.

Business Day:

A day that is not a Saturday, Sunday or a public holiday throughout Western Australia. For the purpose of clauses 9.16.1(b), 9.16.2(e) and 9.16.4(d), a Business Day is a day that is not a Saturday, Sunday, or a public holiday (including a bank holiday) throughout Western Australia and/or Sydney (New South Wales).

Trading Day:

A period of 24 hours commencing at 8.00am WST on any day after Energy Market Commencement, except where the IMO declares that part of a Trading Day is to be treated as a full Trading Day under clause 9.1.1 of the Market Rules, in which case that part is a Trading Day.

Trading Month:

A period from the beginning of a Trading Day commencing on the first day of a calendar month to the end of the Trading Day that finishes on the first day of the following calendar month.

Trading Week:

A period from the beginning of a Trading Day commencing on a Thursday, to the end of the Trading Day that finishes on the following Thursday.
